Background

- RACS is obligated to deliver a Continuing Professional Development (CPD) Program under it's accreditation with the AMC/MCNZ
- A review of the CPD Program occurs approximately every 3 years to ensure it aligns with regulatory requirements and retains relevancy to our members
- The Medical Council of New Zealand (MCNZ) has recently revised it's <u>CPD Framework</u> for implementation by 2022 and the Medical Board of Australia (MBA) is in the process of finalising it's review which is expected to align with it's <u>Professional Performance</u> <u>Framework</u> (2018)

CPD Program - 2020 (Jan – Dec)

In recognition of the impact the 2020 year impacted many Fellows, the following adjustments to CPD requirements have been made:

- Up to 10 points can be claimed for COVID activities in Category 2: Clinical Governance.
 This will meet the full requirement for this category in 2020.
- An additional 10 points can be claimed for General Activities in Category 3: Maintenance of Knowledge and Skills. This increases the annual threshold to 30 points and recognises the significant reading and research activities many surgeons have undertaken this year.
- To assist in meeting the Category 4: Reflective Practice requirement, an online activity is under development and will be available to all CPD participants in October
- No Fellow will be subjected to verification for their 2020 participation

CPD Program - 1 Jan - 30 Jun 2021 (Transition Phase)

- 6 month period interim program
- Fellows must complete 2 out of 3 activities:
 - Complete a Learning Plan
 - Complete the RACS CPD Program 2021 microlearning activity
 - Register and attend Specialty Association or Society scientific meeting or RACS Annual Scientific Congress (ASC)

Due date 30 June 2021

- Compliance period 1 July 2021 30 June 2022
- Program Requirements:

1. Audit	Audit of self / own practice	One (1) per annum		
2. Performance Review	Performance related to self	At least one (1) per annum		
	Performance related to others	At least one (1) per annum		
3. Education activities	A minimum of 40 hours over two or more activities per annum	40 hours per annum		

CPD Program: 1 July – 30 June

- Area of Practice (technical and non-technical competencies) to direct CPD participation recommended that a minimum of 50% of CPD must be aligned to a Fellows area of practice
- Area of Practice to be defined by Fellows/Participants
- Verification to increase to 10% per annum with selection algorithm adjusted to minimise repeat selection/increase sample population
- CPD will be due 31 August
- Non-compliant Fellows to be reported to MBA & MCNZ
